Regular Monthly Minutes
July 9th, 2024 5:30pm

The City of Crab Orchard held its regular monthly meeting on July 9, 2024 at 5:30pm. Mayor Emmett Sherrill and Alderlady Winona Christopher were in attendance, Alderman Mike Findley was not in attendance. Mayor Sherrill called the meeting to order.
